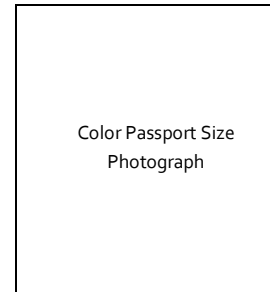

Terms & Conditions

1. The aspirant will be required to undergo screening test and interview to ascertain his / her eligibility, merit and suitability for a particular course to which admission is sought. Mere act of application does not entitle the aspirant to acquire or claim towards his/her selection/admission. Decision of the selection committee in this regard will be final and binding on the applicant.
2. The aspirant must submit truthful and correct information in the application form. Any attempt of falsehood may disqualify the applicant and may invite further action under the law, even at a later date.
3. The selected candidate will be required to pay registration and course fees. Payment of registration fees secures admission for the selected candidate. He /She is allowed to pay the course fees within 15 days thereafter. Default in payment of course fees will result in the cancellation of the selection and in that case, Registration fees will be forfeited. Payment of total course fees entitles the student to undergo the Clini-India course for the mentioned duration including course material and evaluation. Fees indicated below are inclusive of taxes as applicable currently. The student will be liable to pay additional amount towards any further taxation if and when notified by the government consequently. Fees once paid will not be refunded under any circumstances.
4. Course content in the field of Clinical Research is dynamic. The curriculum of various courses may be modified from time to time in the interest of the students. The right to modify/alter the course vests with administration of Clini-India.
5. The didactic part of course of instructions will be imparted at current location of Clini-India. The Academy may shift its location to a reasonably accessible place in another campus for didactic training. The student may be required to attend the classes at such a place.
6. The students cell at Clini-India will offer help in career counseling, educational counseling, mentoring and placement. This is a benevolent gesture from Clini-India, offered in good faith towards Human Resource Development. There are no commitments made by Clini-India or no legal bindings offered thereby.
7. Admission to any course at Clini-India is matter of solicitation by the aspirant. Clini-India will endeavor to instill the best possible educational inputs.
